



Student Delegates'
Hotel

The Local Arrangements Committee recommends the Hotel

Figueroa at Tenth and Figueroa Streets, Los Angeles, for the housing of student delegates. This hotel is near the YWCA and within five blocks of General Head-quarters. Mrs. Roy Smith, official hostess to the students, can be found in the assembly room for students in the Biltmore Hotel. A beach party is planned for all students for Thursday afternoon.

First Showing of "The White Angel"

Another last-minute piece of news is the announcement that

the première showing of the Florence Nightingale motion picture "The White Angel" (produced by Warner Brothers see pages 574-575 of this *Journal*) will take place Wednesday evening, June 24, in Los Angeles, at the Warner Brothers' Downtown Theater, 7th and Hill Streets; and at the Warner Brothers' Hollywood Theater, Hollywood Boulevard and Wilcox.

Plans have been made for delegates who wish to spend happy vacation days in Southern California. One is an eleven-day trip, including the chief points centering in and about Los Angeles and going south to San Diego and Old Mexico—as well as north to Santa Barbara, San Francisco, and the bay cities—at an average cost of \$7.00 a day, with a maximum of \$9.70. This includes room with bath, meals and transportation (except for Santa Barbara and San Francisco, which is included in regular train fare to Los Angeles).

A two-day trip is planned to San Diego and Old Mexico, along the beautiful coast

route to San Diego, by ferry to Coronado, and over the Silver Strand to Tia Juana, Mexico, with its colorful cafés and shops. After returning to San Diego for the night, the second day is spent in Balboa Park, scene of the Exposition. On the return trip you stop at San Juan Capistrano Mission, which was completed the year the Declaration of Independence was signed. The parlor car tour is \$8.00, plus a small border fee, or the trip may be made by steamer, rail, or stage. The trip for the two days, including hotel accommodations and meals is \$17.50.

June 28 has been designated as Nurses' Day at the California International Exposition at San Diego. At a program to be given in the outdoor amphitheater, the speakers expected to give brief talks are Clara D. Noyes, Major Julia Stimson, and Edith Bryan. Another feature of the day will be a display of baby layettes of early days, showing Spanish, Italian, and Indian preparations for the family's new arrival. A two-day trip is planned by the Exposition officials providing for special auto buses from Los Angeles to San Diego, routed through the Orange County citrous groves, and past historic San Juan Capistrano.

The United Fruit Com-Transportation pany offers an attractive Homereturn trip on "Great White Fleet" ships, leaving Los Angeles on June 27 and arriving in New York on **July 12.** Change of steamers is made at Panama, the passengers stopping over two days in Balboa and Cristobal, and one day in Havana. The fares from Los Angeles Harbor to New York are from \$215, according to accommodations occupied, hotel stopover and railroad transfer in the Canal Zone included at no extra cost.

for Examination and Registration of Graduate Nurses. Miss Squier is a graduate of St. Paul's School of Nursing, Dallas, Texas and has done postgraduate work at Cook County Hospital, Chicago, Illinois, where she was also supervisor of the Pediatric-Orthopedic Department. She received her B.A. degree from the University of Texas, and recently has been on the faculty of the Multnomah County Hospital School of Nursing, Portland, Oregon.

The Florence Nightingale medal, the highest Red Cross decoration that can be bestowed upon a nurse, was proposed and adopted in 1912 at the Ninth International Red Cross Conference at Washington, D. C. Originally intended as an award for conspicuous service in time of war, then restricted to those who gave actual care to the sick and wounded, it has, with the changing programs of Red Cross Societies, been modified to include outstanding service in related fields of nursing. The medals are awarded every two years by the International Committee of the Red Cross upon recommendations made by Na-

tional Red Cross Societies. Altogether, twenty-one medals were distributed in 1935; one of these came to an American Red Cross nurse, Mrs. Elsbeth H. Vaughan, Director of Nursing, Midwest Branch of the American Red Cross. It was awarded to her on May 11 by Admiral Cary T. Grayson, Chairman of the Central Committee of the American Red Cross. The award was made at the time of the annual convention of the American Red Cross which was held this year, in Chicago, Illinois.

Admiral Grayson preceded the actual presentation of the medal by the following remarks:

Mrs. Vaughan was born in Switzerland, coming to this country when quite a young child. Her preliminary education was received in the public schools of Detroit. Entering the Farrand School of Nursing in connection with the Harper Hospital, Detroit, she graduated in 1904. She remained with this institution for two and one-half years as a supervisor. A wide experience in the institutional field which included that of assistant superintendent of Saginaw General Hospital; as surgical nurse with the Mayo Brothers, Rochester, Minnesota; and later as supervisor of operating rooms at the Harper Hospital, Detroit; followed by five years as Director of Public Health Nursing of the Department of Health of Detroit, laid a firm foundation for the important service that awaited her with the Red Cross.

Enrolling in the American Red Cross Nursing Service early in 1917, Mrs. Vaughan came to Red Cross Headquarters in Washington, as Assistant to the Director of Nursing Service where she helped with the assignment of nurses to military service. Leaving the Red Cross in May 1919 she returned to Michigan, serving until 1921 as Assistant Director of Public Health Nursing Service with the State Department of Health.

Ås the Red Cross was engaging in an extensive postwar child welfare program in Europe, Mrs. Vaughan in August 1921 again entered Red Cross service to assist with its promotion. She was appointed Assistant Director of the Nursing Service of the American Red Cross Commission to Europe where she remained until September 1922, rendering exceptional service in the organization and development of this program in Latvia, Esthonia, and Lithuania. As there were few nurses in those countries and none with public

health training, she succeeded in securing the interest of local medical and educational groups with the result that a course in public health nursing was established at the University of Dorpat, Esthonia, the first of its kind in that part of the world. Upon her return she was again connected with the Michigan Department of Health, remaining there until 1924 when she returned to the Red Cross as Assistant Director of Nursing; first with the Branch Office at Chicago, then in the same capacity in the Midwest Branch Office of the American Red Cross, in St. Louis, from which office she has supervised the Red Cross nursing program in seventeen states of the middle west.

Mrs. Vaughan's long and distinguished service to the American Red Cross, during which period she has upheld the ideals and standards of the organization, qualifies her for this outstanding recognition of her devoted service. It, therefore, gives me great pleasure to bestow upon her for the International Red Cross Committee of Geneva, Switzerland, as well as for myself, Chairman of the Central Committee of the American Red Cross, the Florence Nightingale medal.

The eight-hour day for Eight-hour nurses went into effect Feb-Dayruary 1 in two hospitals in Council Bluffs, Iowa, and is proving satisfactory.

At a recent meeting of the Alumnae Association of the George F. Geisinger MEMORIAL HOSPITAL SCHOOL OF NURS-ING, Danville, Pennsylvania, it was unanimously agreed that the alumnae association approve eight-hour duty in the Geisinger Memorial Hospital and plans are being made to put it into effect as soon as minor details are arranged.

At the spring meeting of the Rhode Island State Nurses' Association, April 30, Providence, Mary E. G. Bliss spoke on "Eight-hour Nursing," giving new impetus to Rhode Island nurses who are anxious to bring about eight-hour nursing. One of the Rhode Island hospitals-the Newport Hospital-is using the plan successfully.

The Huntington Maternity (West Virginia) CHAP-Institute in TER, AMERICAN West Virginia Cross has recently sponsored a maternity institute, conducted

by Anita Jones of the Maternity Center Association, New York, and stressing the need for more adequate maternity care.

Learning Hospital Administration

The March 1936 issue of Hospitals reports on an interesting experimental program in hospital ad-

ministration at the University of Chicago School of Business, begun in 1934-35 with six students and continued this year with eight. The students have been young physicians, recent college graduates with some business training, and older graduates, one of whom in each year has been a nurse. The program has been open only to those who hold the B.S., the M.D., or the D.P.H. degree. In addition to academic work in the university, field work is arranged for each of the four quarters and an internship of from six months to a year in a selected hospital is also considered an essential part of the course.

The plan at the University of Chicago does not as yet provide for persons without an academic degree. The student possessing an academic degree and having appropriate background of undergraduate preparation should be able to complete needed work in hospital administration and the requirements for the master's degree in four quarters at the University, plus the internship noted above.

History of Nursing in Preparation The ILLINOIS STATE NURSES' ASSOCIATION is sponsoring publication of the history of nursing in

Illinois. Data of historic interest and importance are being collected and some work has already been done on writing the history.

New School of Nursing in Palestine Actual construction of the Rothschild-Hadassah-University Hospital and Medical School, Palestine's first medical center,

is to begin this summer on Mt. Scopus, outside the wall of Jerusalem. One of the three units of structure will be the nurses' school and residence which will be known as the Henrietta Szold School of Nursing as a tribute to the founder of Hadassah.

Fraudulent Soliciting for Relief Funds A solicitation was recently made in Sioux City, Iowa, by a woman who claimed to be a collector for the Nurses' Relief Association of Amer-

ica. The Iowa State Nurses' Association has informed the Sioux City *Tribune* that the State Nurses' Association has not authorized any person to make an appeal for money.

Nursing at the Women's Pageant of Progress

presented an exhibit and a group of short dramatic scenes interpreting nurses and nursing to lay groups at the Women's Pageant of Progress in Chicago, in April. One performance put on by students of the Cook County School of Nursing was entitled "Scenes from Freshman Week in a School of Nursing." The Cook County Rural Public Health Nursing Service, the Illinois League of Nursing Education, the Central Council for Nurs-

ing Education, the American Red Cross, the students of St. Luke's Hospital School of Nursing, and the Visiting Nurse Association participated in other programs dramatizing visiting nursing, hourly nursing, the nursing school, and the nurses' registry. In spite of a small stage and the continuous movement and confusion found in a Pageant of Progress, the spectators were too interested to leave during the short performance.

An exhibit displayed the services of public health, Red Cross, and private duty nurses. Leaflets, When You Need a Nurse, and One Hourly Nurse—descriptive of the services available at the nurses' official registry of the First District—were distributed, as well as calendars. Through the commissions on the sale of general admission tickets and thermometers, a substantial sum of money was raised which is to be used for a milk fund.

Suggestions
The program of the institute, sponsored by the Private Duty Section of District 1, Illinois State Nurses' Association, April 2–3, included sections on the medical and nursing treatments of contagious disease and obesity. Other subjects of lectures, demonstrations, and motion pictures included "Tuberculosis and Modern Thoracic Surgery," "Oxygen Therapy," "Orthopedic Nursing," and "Psychiatric Problems in General Nursing."

At the April meeting of the NURSING EDUCATION CLUB of TEACHERS COLLEGE there was a discussion of the Social Security Act and its implications in the field of nursing.

The Pennsylvania League of Nursing Education, in conjunction with the Pennsylvania Tuberculosis Society, recently arranged, in different localities of the state, four one-day institutes on tuberculosis. At the morning and afternoon sessions a doctor and a nurse, both well qualified to instruct on tuberculosis, presented the newer aspects and the nursing care of the disease. At the luncheon meeting, open to the public, there was an address on "What the Layman Needs to Know about Tuberculosis."

DISTRICT 10. NEW YORK STATE NURSES' Association (Mohawk Valley) recently held a very successful two-day institute, for which 151 nurses registered. To pay expenses, a fee of 50 cents for a day or 25 cents for a session was charged. Recent Meetings

COLORADO STATE NURSES' ASSOCIATION, COLORADO LEAGUE OF NURSING EDUCA-TION, and COLORADO HOSPITAL ASSOCI- ATION, April 27–29, Denver. This was the first joint meeting of the three organizations with approximately five hundred nurses and hospital executives in attendance.

Guest speakers included Mary M. Roberts, Dr. Malcolm T. MacEachern, and Dr. Arthur C. Bachmeyer. Problems of hospital nursing service were discussed as well as the chaotic condition in which nursing education finds itself today. Suggestions that might lead to improvement were made by Miss Roberts who stressed better community relationships, and left with the nurses a distinct challenge as to what must be done in order to "march forward in nursing education." Dr. Mac-Eachern made a plea to hospitals to assist nurses in their efforts to reach a more stabilized academic level. A national system of accreditment of schools of nursing was suggested by Dr. Bachmeyer as a means of bringing about greater acceleration in the rate of improvement in nursing schools.

NEW MEXICO STATE NURSES' ASSOCIA-TION, April 30-May 2, La Fonda Hotel, Santa Fe, with between eighty and ninety nurses registered. An interesting group of papers and addresses included the following: "New Mexico's Program for Crippled Children," by Jeanette Jansen, Supervisor of Crippled Children's Work. Roberts, Editor, American Journal of Nursing. Other subjects discussed were "Psychology of the Interview," by Jessamine Whitney, New York City; "New Standards of Public Health Nursing," by Anna Heisler, San Francisco; and "Tuberculosis Among Nurses," Robert O. Brown, M.D., Santa Fe. At an evening session a motion picture of collapse therapy by Le Grand Ward, M.D., was an interesting feature of the program.

NEW JERSEY STATE NURSES' ASSOCIATION, NEW JERSEY STATE LEAGUE OF NURSING EDUCATION, and NEW JERSEY STATE OR-GANIZATION FOR PUBLIC HEALTH NURS- ING, April 22–24, Asbury Park. All meetings were unusually well attended; twenty-six student nurses were in attendance, representing ten schools.

At the combined business session, all of the reports indicated increased activity and a wider range of thinking and planning. This was particularly true of the reports of district presidents, all of which have active committees studying nursing bureaus as community service agencies and the eighthour day system for all nurses. Five districts increased their membership last To date, all districts have reported greatly increased paid-up membership over the same period last year, increased attendance at meetings, and greatly increased interest in their planning for handling local problems. OHIO STATE NURSES' ASSOCIATION, May 6-9, Columbus. Although 776 nurses registered, the auditorium, with a seating capacity of 1200, was taxed to utmost ca-The presentation of reports from the sixteen districts at the Advisory Council meeting which representatives of the sixty-five alumnae associations also attended, was a new venture and proved to be most desirable as it offered an opportunity to discuss programs. Some of the topics discussed in the open forum, conducted by the president of the Ohio State Nurses' Association, were: membership, salaries and working conditions of general staff nurses, the eight-hour day, making postgraduate work financially possible, and subsidiary workers in the hospital.

structive Surgery of the Head, Including Cleft Palate" by Hugh Beatty, M.D., Columbus; a symposium on "Conservation of Vision Among Children" by Albert Frost, M.D., Ohio State University, and Mrs. Francia Baird Crocker, National Society for the Prevention of Blindness, New York City (the Ohio Commission for the Blind coöperated in arranging for these speakers and provided exhibit material, charts, et cetera); "Health Education in Schools," by John Sundwall, M.D., University of Michigan, discussed by Dorothy Rood, Ph.D., Ohio State University. Ruth A. "The Nurse Practice Act—A Protective Device for the Community," by Elizabeth Burgess, Professor of Nursing Education, Columbia University; "The Nurse Practice Act in Virginia 1903–1936," by Josephine McLeod, Superintendent of Nurses, University of Virginia

Hospital; "Recent Problems Met in Administering the Nurse Practice Act in Virginia," by Ethel M. Smith, Secretary-treasurer of the State Board of Nurse Examiners and Inspector of Schools of Nursing; and "The Technic of Advancing Standards," by Netta Ford, President of the Pennsylvania State Nurses' Association, were papers presented by the Educational Section.
